- Coordinate and provide payment for tournament table workers and deposits as required.
- ✓ Reports to State regarding financials as required.

Take a ways from the meeting:

- Clubs that work the tables will make \$100.00 for a full day if they work a table for the day (rookie through open) at any local tournament paid by the region at the end of the day.
- With the exception of the first two tournaments, due to the low entry numbers, the region has agreed to pay the official's 3.00 an entry divided by the number of officials (according to TX USAW guidelines including the minimum of \$100.00 an official (the higher of the two) for the local tournaments.
- > All Regions with TXUSAW will register all tournament entries on Trackwrestling
 - Central Region passed a request to require online payment requirement for those entries entered for the local tournaments passed.
 - Clubs can determine if they will allow each parent from their club to register themselves for the tournament or if the club will register and pay as a team.
- Jim Dorsey discussed rule changes please see the TXUSAW website for a listing of all of those changes.
- HOT- the region will not be able to rent the Delco Center due to the HS District tournaments will be held the same weekend as HOT, we are checking into a new facility in Round Rock and will keep everyone posted. We will run a rookie tournament with the HOT this year as Novice state is in Houston with Houston Nationals this year.
- We received requests for mats from the meeting, it was requested that <u>all requests are put in writing and sent to the region</u> and after inventory is collected on what mats the region owns and if there are any available for use, along with quotes on the purchase of mats, the region will contact the clubs as soon as we can to assist in any way we can. Will keep you posted. Still working on getting these mats bought and distributed

- HS and youth preseason tournaments- 9/28; 10/19 and additional one in October; date to be determined. All wrestlers have to have their USAW Cards and entry fees to enter.
 Flyers will be posted to the website and sent out in email as soon as possible.
- Matthew Gochberg will continue to host the mandatory Coaches clinic dates and times to be determined.
- Tournaments can be held on Saturday and Sunday. Please review the UIL HS schedule before booking a Saturday and make sure you have official coverage for the tournament you are booking prior to putting down the venue deposit and etc.
- Any club wanting to host a tournament this year or next year please email us as soon as possible, or who was on the schedule last year and does NOT want to host a tournament this year please let us know as soon as possible.
